President Report:

MSM developed a website that should be completed July 1st. Randy Truitt Owner of MSM will be charging the HOA \$15.00 per month and he will pick up any charges over and above for maintaining the website. We need homeowners email accounts, currently we have only 69 in our contact list. MSM begins serving Tuscany Village on July 1 at an annual cost of \$5,472 vs Kirkpatrick annual cost of \$6,000. Dan read the list of accomplishments during the first 65 days of the new Board. Metronet still had some connection work to complete.

Treasurers Report:

148 member's dues paid to date, 4 still owed for a total of \$1,218, including late fees.

Itemized income and expense report as of May included expenses of \$18,390 and a budget balance of \$25,915. Average spending has been \$3,678/ month. We need to remain within that number to make our budget. May beginning balance of \$35,742.45, ending balance of \$32,476.73, Reserve account balance of \$10,878.44.

Doug Gregg reported ARC Committee activity for June.

Social Committee:

Diane Kane reported the updates for National Night Out event for August 6th

Crime Watch Committee:

Rob Vettiner has volunteered to be our Crime Watch Coordinator.

Unfinished Business:

PPG will be installing a drainage solution in the playground.

Swings in playground will require a special assessment, the Chair made a motion to cancel this project.

The sign was installed in the park May 20th to discourage use by non-residents and to make Police enforcement possible.

PPG began work as our contracted landscaper on June 13th.

New Business:
