- Complete and detailed building plans, picture or brochure of the improvement, materials listing, color of project and size, etc.
- A bid from the professional installer who will be installing your project must be included. **Fences are NOT allowed to be installed in a side or rear yard easement.**
- Official surveyor's plot plan showing the location of the proposed improvement and dimensions

\*\*Please to be sure to include this checklist and all necessary documents with the ACC Committee Improvement Request Form, as incomplete applications will not be processed\*\*

FAILURE TO SUBMIT THE REQUESTED ATTACHMENTS (checklist) PRIOR TO CONSTRUCTION MAY RESULT IN DENIAL OF YOUR REQUEST FOR IMPROVEMENT. If any improvement/change is made without approval, the ACC Committee has the right to inform the homeowner to remove the improvement from the property. The committee also has the right to have the improvement removed at the homeowner's expense.
